Floorplan

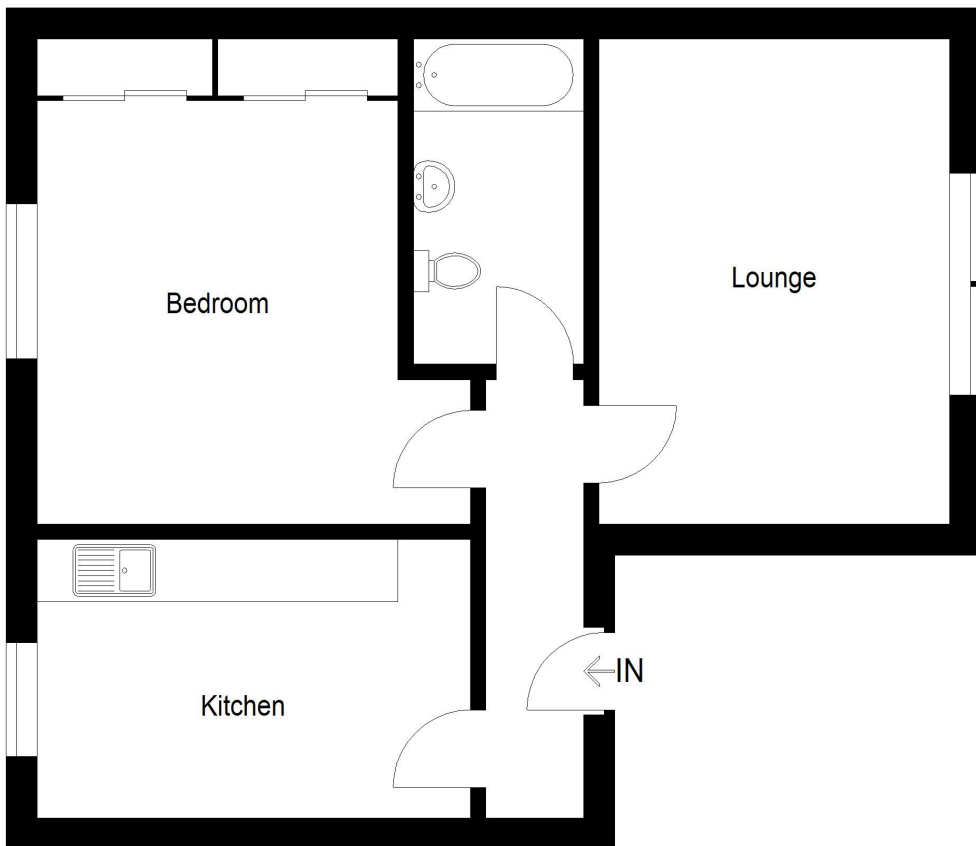
