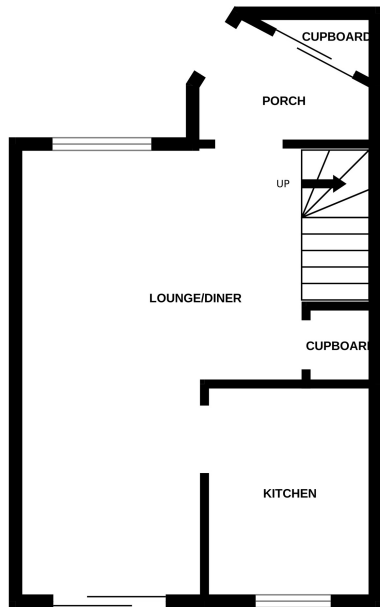




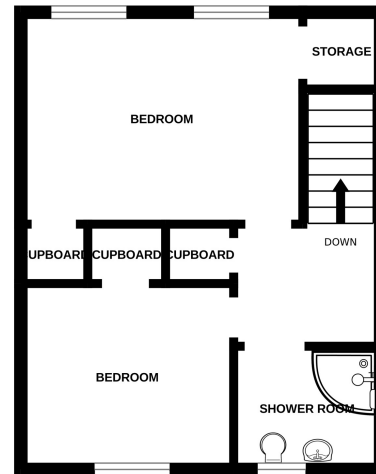


# Floorplan
