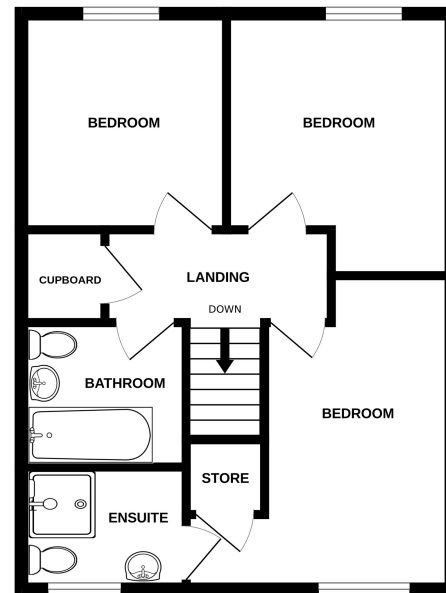


Floorplan
