Summary

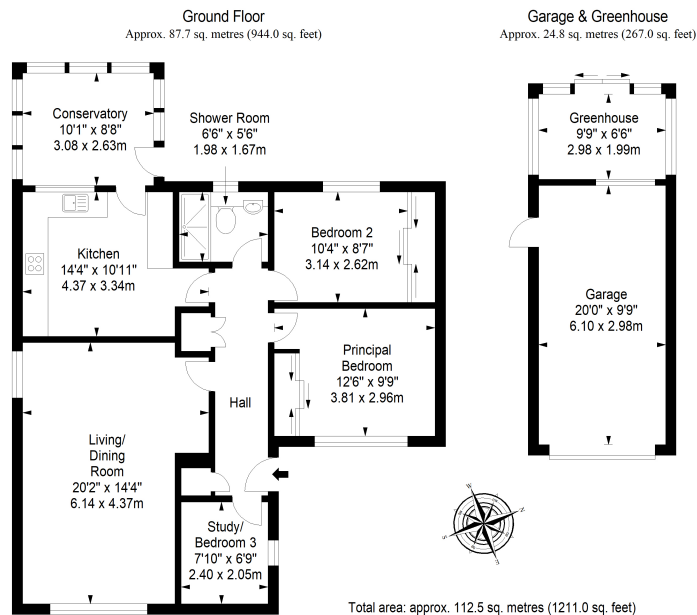
