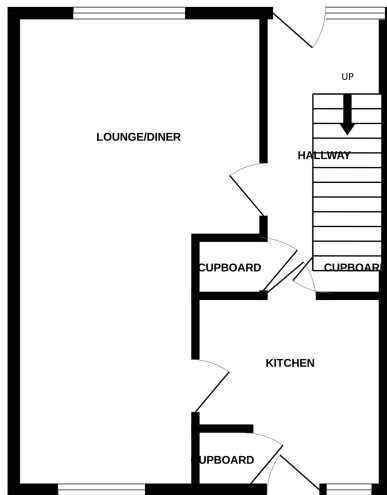




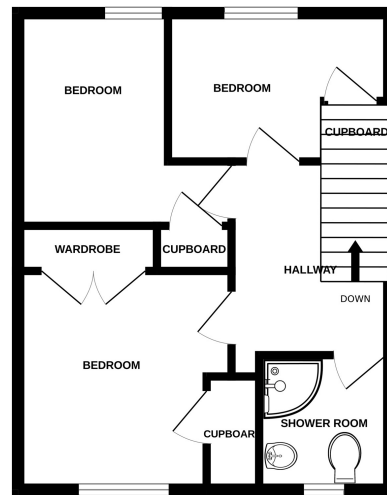


# Floorplan
