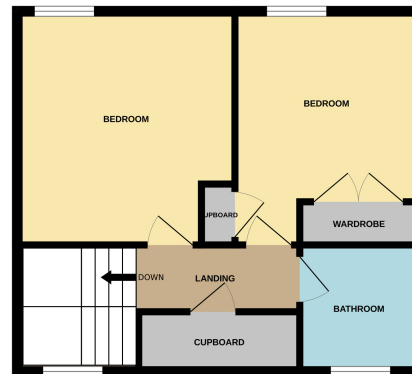


Floorplan
