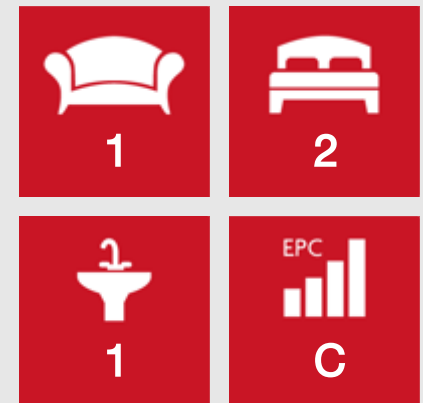

Floorplan

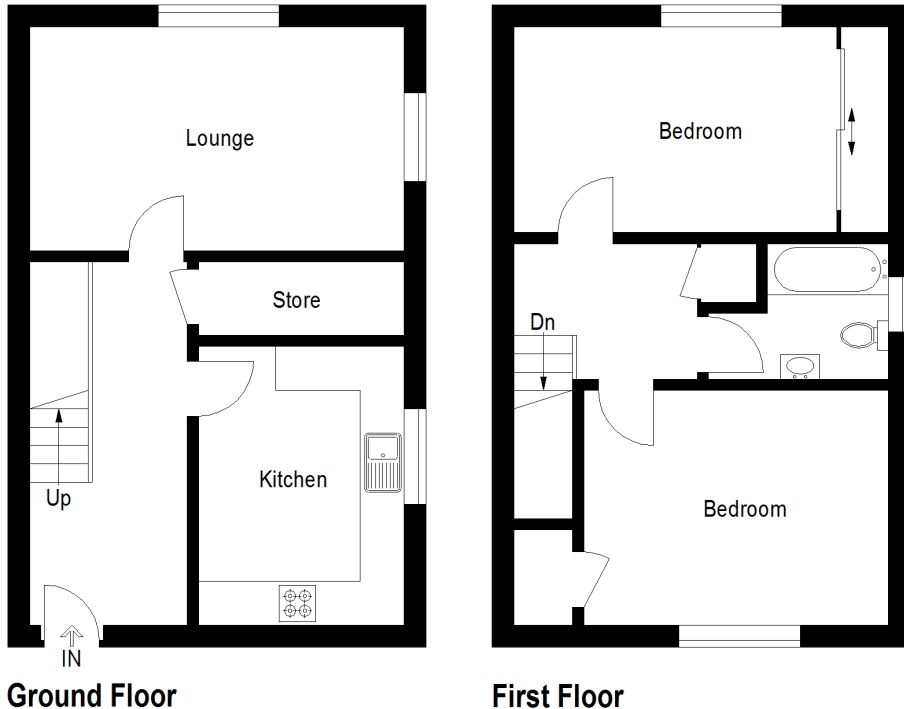
