Garden:

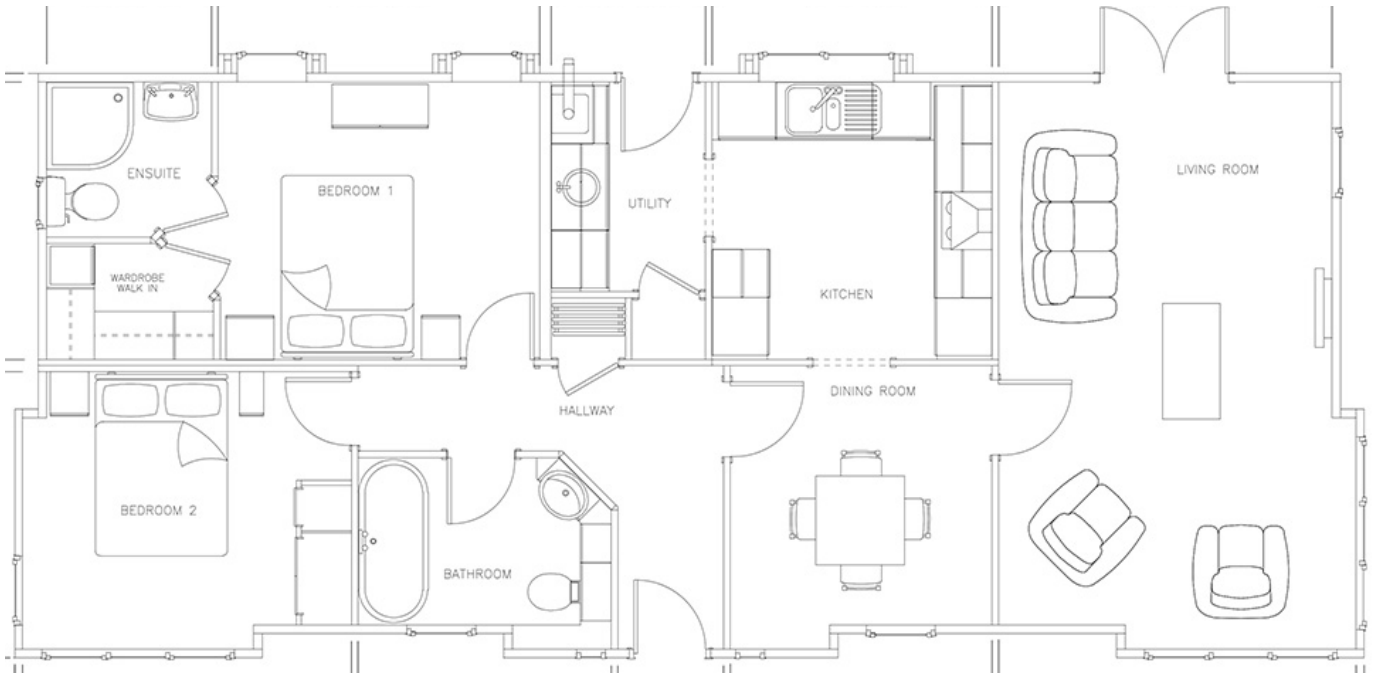

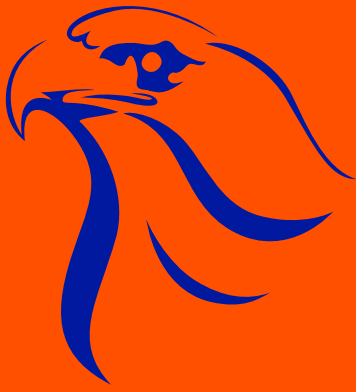
