Floorplan

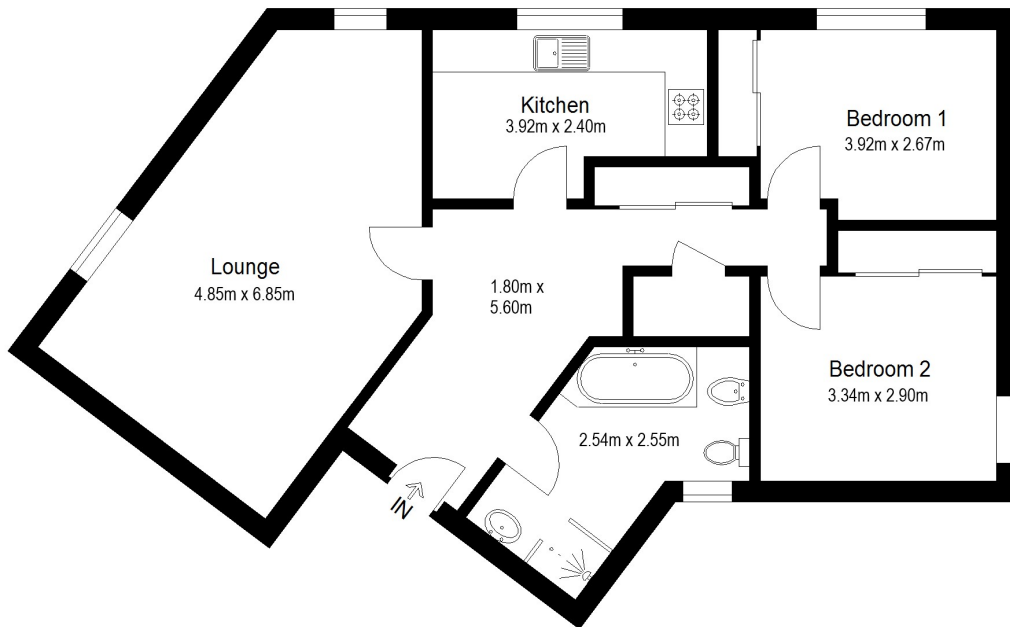
