Summary

This property is the entire upper floor of a substantial, detached villa. The villa was divided into an upper and a lower apartment in 1951. It is situated in a quiet, tree-lined culde-sac in the Maryfield conservation area, and is accessed by its own private staircase. There is a private driveway and an enclosed rear garden. The dwelling comprises two south-facing bay-windowed living rooms, four double bedrooms, one of which is currently used as an office, a bathroom, a shower room and a dining hall with a large walk-in cupboard. 
