Floorplan

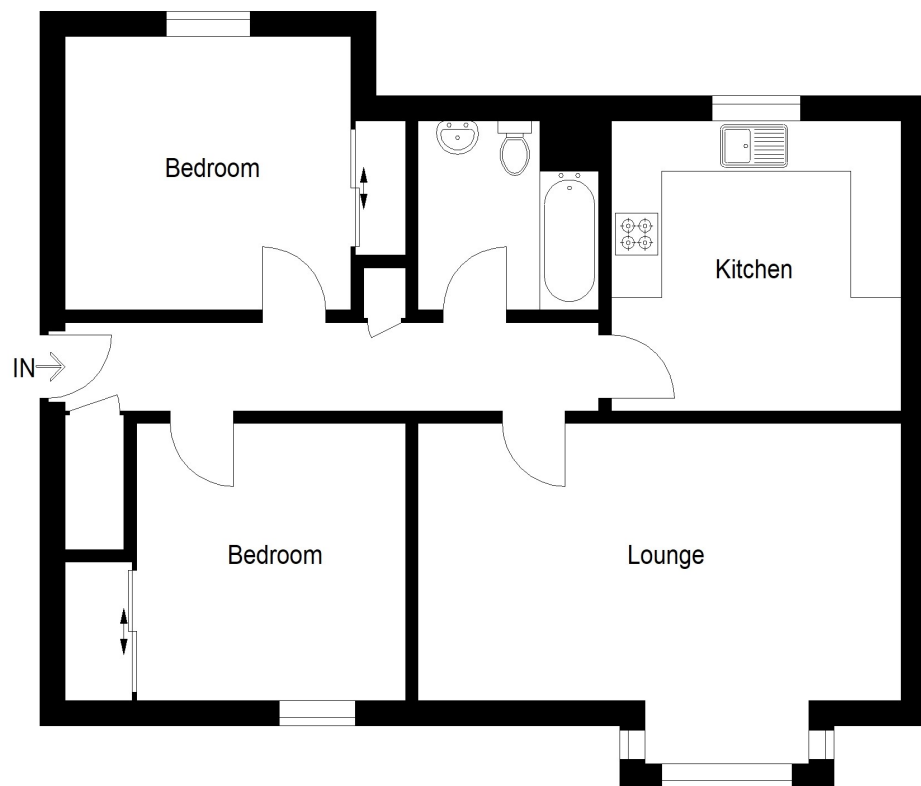
