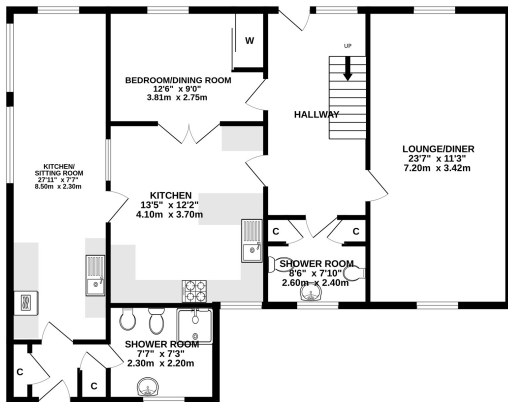

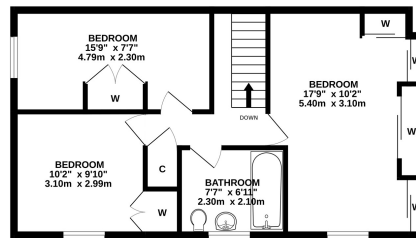


Floorplan
