Bedroom 3:

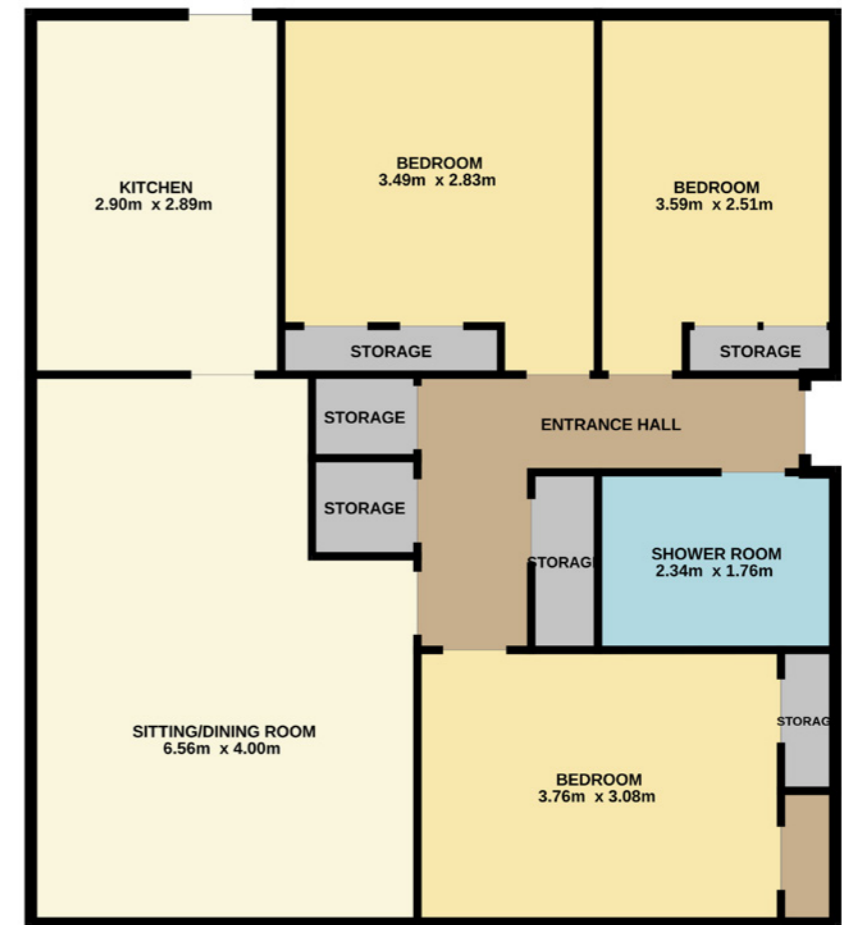
Another generous sized bedroom overlooking the rear garden with built in wardrobe.

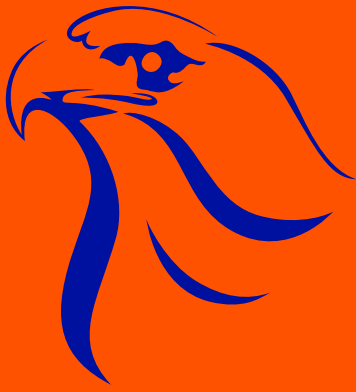
Garden Area:
