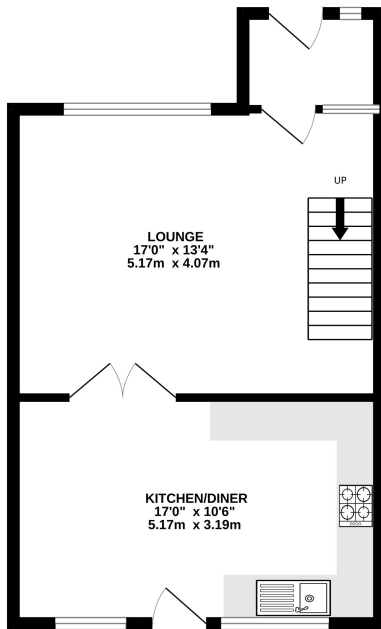

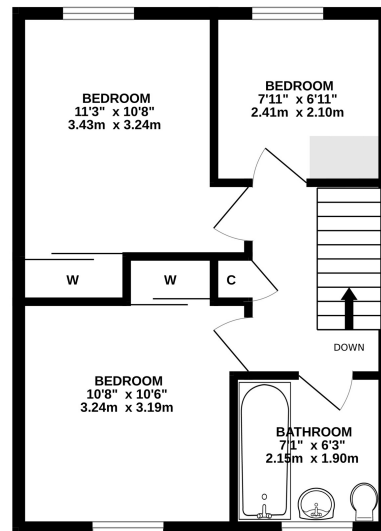


Floorplan
